I understand that the risks of becoming exposed to and/or infected by the Coronavirus/COVID-19 (i.e. illness, disability, death, monetary loss, etc.) may result from the actions, omissions, or negligence of myself and others, including, but not limited to, the owner, director, staff, volunteers, coaches and other dancers, parents, and visitors to the Limitless Dancing Warriorettes, LLC and voluntarily assume risks.

I voluntarily seek services for my child provided by the Limitless Dancing Warriorettes, LLC and assume/acknowledge that I/we/are increasing our risk of exposure to the Coronavirus/COVID-19 by our participation.

I agree/acknowledge that I/we must comply with all set procedures to reduce the spread while attending practices/classes/photo and video shoots/events/functions and appointments.

I attest that:

- I, as well as all household members, am/are not experiencing any symptoms of illness such as cough, shortness of breath or difficulty breathing, fever, chills, repeated shaking with chills, muscle pain, headache, sore throat, or new loss of taste or smell.
- I, as well as all household members, have not traveled internationally within the last 21 days.
- I, as well as all household members, have not traveled to a highly impacted area within the United States of America in the last 21 days.
- I, as well as all household members, do not believe I/we have been exposed to someone with a suspected and/or confirmed case of the Coronavirus/COVID-19.
- I, as well as all household members, have not been diagnosed with Coronavirus/COVID-19 and not yet cleared as non-contagious by the state or local public health authorities.
- I, as well as all household members, am/are following all CDC recommended guidelines as much as possible and limiting my/our exposure to the Coronavirus/COVID-19.

I further agree to immediately notify the Limitless Dancing Warriorettes, LLC if facts or circumstances change such that I can no longer attest to any of the above statements and will withhold my child (dancer) from attending or securing services from the Limitless Dancing Warriorettes LLC if directed to do so after such notification.

I hereby release and agree to hold the Limitless Dancing Warriorettes LLC harmless from, and waive on behalf of myself, my child, my heirs, and any personal representatives of any and all causes of action, claims, demands, damages, costs, expenses and compensation for damage or loss to myself and/or property resulting from the contraction of the Coronavirus/COVID-19 that may be caused by any act, or failure to act of the Limitless Dancing Warriorettes, LLC, or that may otherwise arise in any way in connection with any services received from the Limitless Dancing Warriorettes, LLC.

I understand that this release discharges the Limitless Dancing Warriorettes, LLC from any liability or claim that, my heirs, or any personal representatives may have against the Limitless Dancing Warriorettes, LLC with respect to any bodily injury, illness, death, medical treatment, or property damage that may arise from the contraction of the Coronavirus/COVID-19, or in connection to, that may result from participating and/or receipt of any services received from the Limitless Dancing Warriorettes, LLC.

This Liability waiver and release extends to the Limitless Dancing Warriorettes, LLC together with all owners, directors, staff, coaches, volunteers, partners, employees, volunteers and dancers.
